## What is the ATFA?

Alabama TREASURE Forest Association members are stewardship-minded men and women dedicated to improving the forestlands of our state and nation. These lands are managed for multiple uses, including wildlife habitat, pine and hardwood timber resources, clean water, recreation and scenery.

A primary goal of the ATFA is to teach others about responsible forest management. While we recognize every forest landowner has different objectives for owning their land, we hope someday all forestlands in Alabama are managed according to the TREASURE Forest philosophy. Every landowner can use this philosophy to reach their goals.

In the fall of 2013, ATFA enhanced these efforts by partnering with the largest landowner organization in the state, the Alabama Farmers Federation. This affiliation leverages Alfa's grassroots organization of over 350,000 members, as well as its strength in public policy, research and promotion, to achieve ATFA goals.

In a very real way, the future of Alabama's forests rests in the hands of landowners and like-minded individuals that support them. The ATFA is a 501 (c)3 non-profit, educational corporation.

## TREASURE Forest Program

Started in 1974, the TREASURE Forest program is a voluntary program sponsored by the Alabama Natural Resources Council that seeks to promote sound and sustainable multiple-use forest management. This management encourages landowners to use forests wisely to meet their own needs while protecting and enhancing the environment.

The TREASURE Forest Award is earned by private landowners who display their commitment to the TREASURE Forest ethic through physical management on their land. The TREASURE Forest Award includes a numbered and signed certificate, and TREASURE Forest sign. When the award is given, the land is called a Certified TREASURE Forest, and the landowner is called a TREASURE Forest landowner. Over 2,000 landowners have had their property certified as TREASURE Forests.

# HUNTING LEASE LIABILITY INSURANCE

INSURANCE APPLICATION: FOR HUNT CLUBS ONLY

Hunting Lease Liability provides protection for occurrences arising out of activities and operations of the hunt club and its members, guests or invitees on acreage leased to the hunting club by the timberland owner.
